All Risks Policy

Date:

1. What is this product about?

This policy provides insurance against any loss or damage to the property insured which occurred within the territorial limits.

2. What are the covers / benefits provided?

This policy covers any loss or damage to the property insured or any part of it by accident or misfortune whilst within the territorial limits. The compensation would be provided by repairing, replacing or paying the amount of loss, destruction or damage, depending on your option.

Duration of cover is for one year. You need to renew the insurance policy annually.

3. How much premium do I have to pay?

The total premium that you have to pay may vary depending on the sum insured, the risk exposure and the underwriting requirements of the insurance company.

4. What are the fees and charges that I have to pay?

Duty of Disclosure:

- Failure to take reasonable care in answering the questions may result in avoidance of your contract of insurance, refusal or reduction of your claim(s), change of terms or termination of your contract of insurance.
- The above duty of disclosure shall continue until the time your contract of insurance is entered into, varied or renewed with us.

- In addition to answering the questions in the Proposal Form (or when you apply for this insurance), you are required to disclose any other matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied.
- You also have a duty to tell us immediately if at any time after your contract of insurance has been entered into, varied or renewed with us any of the information given in the Proposal Form (or when you applied for this insurance) is inaccurate or has changed.

b) Non-Consumer Insurance Contract:

- Pursuant to Paragraph 4(1) of Schedule 9 of the Financial Services Act 2013, if you are applying for this insurance for a purpose related to your trade, business or profession, you have a duty to disclose any matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied and any matter a reasonable person in the circumstances could be expected to know to be relevant, otherwise it may result in avoidance of your contract of insurance, refusal or reduction of your claim(s), change of terms or termination of your contract of insurance.
- The above duty of disclosure shall continue until the time your contract of insurance is entered into, varied or renewed with us.
- You also have a duty to tell us immediately if at any time after your contract of insurance has been entered into, varied or renewed with us any of the information given in the Proposal Form (or when you applied for this insurance) is inaccurate or has changed.
- You must ensure that the proposal form is completed accurately as it forms the basis of the insurance.
- Premium due must be paid and received by us within 60 days from the inception date of this policy. If this condition is not complied with then this contract is automatically cancelled and we shall be entitled to the pro rata premium for the period they have been on risk.
- You shall take all reasonable precautions for the safety of the property.
- Upon the happening of any event giving rise to or likely to give rise to a claim under this policy, you shall:
 - (a) Give written notice to us as soon as possible.
 - (b) Take immediate steps to minimize the damage and recover any missing property.
 - (c) Give immediate notice to the police if the claim is for loss or theft.
- You must observe and fulfill the terms, provisions, conditions, clauses and endorsement of this policy.

6. What are the major exclusions under this policy?

This policy does not cover certain losses, such as loss, destruction or damage:

- Caused by or happening through:
 - (a) Vermin, insects, mildew, wear and tear, depreciation or other deterioration or any process of repairing, restoring or renovating;
 - (b) Riot, civil commotion, volcanic eruption, subterranean fire, earthquake or other convulsion of nature;
 - (c) Confiscation, detention, nationalization, requisition or wilful destruction by any government, public municipal, local or customs authority;
 - (d) Mechanical or electrical derangement or scratching or breakage of lenses or glass unless accompanied by other damage for which the insured is entitled to indemnity under this policy;
- Directly or indirectly caused by or contributed to by or arising from:
 - (a) War, invasion, act of foreign enemy, hostilities (whether war be declared or not), civil war, rebellion, revolution, insurrection, military or usurped power;
 - (b) Ionizing radiations or contamination by radioactivity from any nuclear fuel or from any nuclear waste from the combustion of nuclear fuel nor any consequential loss and for the purposes of this exception, combustion shall include any self-sustaining process of nuclear fission; and
 - (c) Nuclear weapons material.
